Pricing for University Colleges and Research Institutions:

Access to the 2017 Full Collection or later collections are offered to university colleges and research institutes for a nominal flat fee of £2,500 per institute. The institution may cancel any individual subscriptions before the licence commences.

The exception to this pricing is Naturalis. The list price for the 2020 Collection including perpetual access to all titles for paid years is £8,833. The price for this collection through the UKB is offered at £6,463. Open Access Publishing:

SCHEDULE 5

TERMS FOR SURFMARKET

1. DEFINITIONS

'**Authorised Users**' an individual who is either a current student, current or retired faculty member or other member of staff of Institution, and whom is authorised by the Institution to access the Licensor's information services via a secure network from a terminal at the Institution's library premise or offsite via a secure link to a valid IP address on the secure network. Such definition shall further include an individual who is not a current student, faculty member or other member of staff of the Institution, but who is permitted to access the information services via the Secure Network from a terminal at the Institution's library premises.

'**Institutions**' shall mean those institutions listed in Schedule 2.

'**Licence Agreement**' means the licence agreement and terms and conditions entered into by an Institution and SURFmarket permitting access to and use of the Subscription Products which is substantially similar to that set out in Schedule 5.

'**Licence Fee**' the fee to be paid by SURFmarket to the Licensor in consideration of the licences granted in clause 2.1 below. Such fee shall be the aggregate of the annual fees paid by the Institutions for access to the Subscription Products as further specified in Schedule 3.

'**Licensor**' shall mean The Chancellor, Masters and Scholars of the University of Cambridge acting through its department Cambridge University Press of University Printing House, Shaftesbury Road, Cambridge CB2 8BS, UK.

'**Subscription Products**' shall mean the products listed in Schedule 1.

2. LICENCE GRANT

2.1 As of 1st January 2017, the Licensor hereby grants to SURFmarket:

2.1.1 a non-exclusive licence to access and use the Subscription Products in accordance with the Licence Agreement attached hereto as Schedule 5;

2.1.2 the right to grant to any Institution which has accepted the terms and conditions of the Licence Agreement access and use of the Subscription Products in accordance with such terms.

2.2 SURFmarket undertakes to only grant licences for the access and use of the Subscription Products to Institutions listed in Schedule 2.

3. RESPONSIBILITIES OF THE LICENSOR

3.1 The Licensor agrees to:

3.1.1 subject to clause 4.1.1 below, provide access and allow use of the Subscription Products to Institutions and their Authorised Users;

3.1.2 allow access by SURFmarket and its employees to the Subscription Products for the purpose of publicising and promoting such products to the Institutions.

3.2 The Licensor reserves the right at any time to withdraw from the Subscription Products any item or part of an item:

3.2.1 for which the Licensor no longer retains the right to publish; or

3.2.2. for which the Licensor has reasonable grounds to believe infringes copyright or is defamatory, obscene, unlawful or otherwise objectionable.

4. RESPONSIBILITIES OF SURFMARKET

4.1 SURFmarket agrees to:

4.1.1. promptly pass the full contact details and IP address ranges of Institutions to the Licensor following acceptance of the Licence Agreement and to provide updates of such lists to the Licensor on a regular basis in the event of any change;

4.1.2 pay the Licence Fee to the Licensor in accordance with the terms of this Agreement;

4.1.3 use best efforts to ensure that the Institutions comply with the terms of the Licence Agreement; and

4.1.4 notify the Licensor immediately on becoming aware of any unauthorised use or other breach and take all reasonable steps to ensure that such activity ceases and to prevent any recurrence.

5. PAYMENT

5.1 The Licensor will invoice SURFmarket for the Licence Fee payable, as set out in Schedule 3, and SURFmarket shall pay the same.

5.2 The Licence Fee is net of all applicable taxes, including without limitation VAT or other applicable sales taxes, which shall be charged in accordance with the relevant regulations in force at the time of making the taxable supply, and such amounts shall be payable by SURFmarket in addition to the Licence Fee on receipt of a valid invoice.

5.3 SURFmarket shall pay the Licence Fee in full without deduction of, or in respect of any tax, unless required by law. If any such withholding or deduction is required, SURFmarket shall when making the payment to which the withholding or deduction relates, pay to Licensor such additional amount as will ensure that it receives the same total amount that it would have received if no such withholding or deduction had been required

5.4 SURFmarket shall pay the Licence Fee in accordance with the payment provisions set out in Schedule 3, and if no such provisions are specified, shall make payment within 60 days of the date of invoice in year 1 of the licence and 30 days for years 2 and 3 of the licence. Without prejudice to any other right or remedy that Licensor may have, where SURFmarket fails to pay the Licence Fee and any VAT or other applicable sales tax on the due date, the Licensor shall be entitled to: (i) charge interest at a rate of 4% per annum above the base lending rate of Barclays Bank plc accruing on a daily basis until the date of actual payment; and (ii) delay the activation of or suspend access to the Subscription Products previously granted until full payment is made of any Licence Fees, and SURFmarket agrees that the subscription period shall not be extended by any period of delay or suspension resulting from late payment.

6. TERM AND TERMINATION

6.1 This Agreement shall continue from the date of signature by both parties until 31st December 2019 unless terminated earlier as provided for in this Clause 6.

6.2 This Agreement shall automatically terminate if either party commits a material or persistent breach of any term of this Agreement and fails to remedy the breach (if capable of remedy) within sixty (60) calendar days of notification in writing by the other party.

6.3 Either party may terminate this Agreement immediately upon notice to the other party if the other party (i) makes or proposes or enters into any arrangement with or for its creditors; (ii) ceases to carry on business or becomes unable to pay its debts; (iii) is declared insolvent by a court of competent jurisdiction, files a petition in bankruptcy, or becomes the subject of any court or administrative proceeding related to its liquidation or insolvency (whether voluntary or involuntary) which is not dismissed within sixty (60) days; or (iv) undertakes any action or has any action taken against it analogous to the foregoing in any jurisdiction.

6.4 Either party shall have the right (in addition to any other rights which it has at law and elsewhere in this Agreement) to terminate this Agreement immediately and without liability for compensation or damages if the other party, or any of its employees commits any act which brings or is likely to bring the terminating party into disrepute or which in such party's reasonable opinion is prejudicial to its interests.

6.5 Upon termination or the expiry of this Agreement, the Licensor shall cease to authorise all on-line access to the Subscription Products by Institutions and Authorised Users. All rights under this Agreement and the Licence Agreement will be automatically terminated, except for such rights of action as will have accrued prior to such termination and any obligation which expressly or impliedly continues in force after such termination.

6.6 In the event of a breach of an Institution's Licence Agreement, SURFmarket shall notify the Licensor as soon as reasonably possible after becoming aware of such breach. The Licensor reserves the right to terminate the relevant Institution's access to the Subscription Products.

6.7 On termination of this Agreement by SURFmarket under the provisions of clause 6.2 above, the Licensor shall promptly and within sixty (60) days refund the proportion of the annual Licence Fee that represents the paid but un-expired part of the subscription period (as detailed in the Contract Form).

6.8 Member Institutions may terminate their agreement if sufficient funds are not provided or allotted in the library budget for the products by the appropriate body in the Member's institution. The Vice Chancellor of the Member's institution shall provide a written statement to the CUP in which the Vice Chancellor confirms the significantly decreased budget allocation to the Member Institution. Notice of such a decision must reach the CUP by 1 November at the latest for implementation at the commencement of the next calendar year.

6.9 In the event that this licence is terminated in accordance with clause 6.8 above then clauses 6.5 - 6.7 shall apply.

6.10 The Licensor adheres to the TRANSFER Code of Practice: Version 2.0, as further detailed in Schedule 4.

7. ACKNOWLEDGEMENT AND PROTECTION OF INTELLECTUAL PROPERTY RIGHTS

7.1 Subscription Products, usage data and usage reports are protected by international copyright laws, database rights and other intellectual property rights. Licensor, its affiliates and licensors are the owners of these rights, and this Agreement does not transfer any right, title or interest in the Subscription Products to SURFmarket.

7.2 Licensor warrants that use of the Subscription Products in accordance with these terms does not infringe the intellectual property rights of any third party.

8. REPRESENTATION, WARRANTIES AND INDEMNIFICATION

8.1 The Licensor warrants to SURFmarket that the Subscription Products and all intellectual property rights therein are owned by or licensed to the Licensor and that the Subscription Products used as contemplated in this Agreement and the Licence Agreement do not infringe any copyright or other proprietary or intellectual property rights of any natural or legal person. 8.1.1 the use of the Subscription Products has been in full compliance with the terms and conditions of this Agreement and the Licence Agreement as applicable;

8.1.2 SURFmarket provide the Licensor with prompt notice of any such claim or threat of claim;

8.1.3 SURFmarket co-operates fully with the Licensor in the defence or settlement of such claim; and

8.1.4 the Licensor has sole and complete control over the defence or settlement of such claim.

9 ANTI BRIBERY AND CORRUPTION

10.1 SURFmarket understands that Licensor acts in accordance with the UK Bribery Act 2010 and other applicable anti-bribery laws in the jurisdictions in which it operates. This clause 11 shall survive the termination of this Agreement.

11 GENERAL

12.1 SURFmarket may not assign, transfer or sub-licence its rights or obligations under this Agreement.

12.2 In no circumstances shall Licensor be liable to SURFmarket for any delay or failure to perform its obligations due to an event beyond its reasonable control, including but not limited to, loss or failure of third party controlled IT equipment and internet connections.

SCHEDULE 6

Open Access

Terms and Conditions for Open Access Publishing for Authors

1. Eligible authors

Eligible Authors are defined as teaching and research staff employed by or otherwise accredited to one of the Institutions as well as students enrolled or accredited to one of the licenced Institutions.

In case of articles published by multiple authors, the corresponding author will be the Eligible author. Corresponding author shall be the author who signs the publishing agreement.

Authors are only eligible once they have signed the then current open access publishing agreement with Publisher. Currently this agreement refers to any of the below Creative Commons licences:

- Creative Commons Attribution License (CC-BY)
- Creative Commons Non-Commercial License (CC-BY-NC)
- Creative Commons Non-Commercial No-Derivatives License(CC-BY-NC-ND)
- Creative Commons Non-Commercial Share-alike (CC-BY-NC-SA)

2. Eligible Article Types

This agreement provides for unlimited publishing of research and review articles by Corresponding Authors within our hybrid and fully-OA journals.

3. The parties' obligations

a) The parties have the following obligations regarding the Open Access Publishing:

- Publisher shall not levy article processing charges directly on Authors who have identified themselves and whose eligibility has been verified;
- Publisher shall list and include the Institutions in the publishing process in order to assist Authors in identifying themselves at the time of submission;
- Authors will be deemed Affiliated Authors if the email address they provide to the Publisher is part of the list of domain names of the Institutions provided in Appendix
- Informational text in RightsLink (or whichever system the Publisher may utilize in future) will be displayed for authors linking to the Publisher's website for further details on the possibilities to publish in Open Access for free.
- Information regarding the agreed licence in regard to publishing in Open Access will be posted on the Cambridge Core website.
- Authors are given a choice in publishing routes at the time of submission. However, the Publisher's website will clearly be referenced to enable Authors to view the Open Access policies and allowances within this agreement.
- Institution shall ensure that Authors shall identify themselves as being both eligible and corresponding in the course of the Publisher work-flow. In case authors have not identified themselves as being eligible and corresponding, once an article has been published in a subscription Journal, the author is not eligible anymore to publish the article as Open Access;

- The parties might change this identifying process and amend this Agreement accordingly, when the changes and amendments are agreed by both parties.
- If the Agreement between Parties becomes available after the starting date, Parties will agree on publishing articles in Open Access for three years starting from 1 June 2017.
- Publisher will where appropriate provide an automated article upload service to PubMed Central.

b) Publisher will deliver a monthly report per institute of the articles that have been published in Open Access in hybrid journals or fully OA journals in each month. The report gives an overview of the corresponding author(s), the affiliation of the corresponding author(s), the article title and journal volume, per institute. The report will be delivered within 4 weeks after the end of each month.

c) Publisher will deliver a full report of all articles (open access and otherwise) published by the Institutions over the period 1 January until 30 June and 1 July until 31 December. The report gives an overview of the Institutions, the corresponding author(s), the affiliation of the corresponding author(s), the article titles, journal volumes and open access Y/N. The report is delivered within 4 weeks after the end of the 6 month periods. The report will be sent to SURFmarket, or an appointed contact person of the Institutions.

d) Publisher is working to support the NISO Access and License Indicators Metadata, which we see as a useful standard. Currently, we record in JATS XML that the article is Open Access and which Creative Commons license is applied to the article.

LICENCE TERMS FOR INSTITUTIONS



1 DEFINITIONS

In this Agreement the following words shall have the following meanings:

Agreement: the Contract Form and these Licence Terms;

Annual Access Fee: the annual fee for providing Online Access to the Products; the fee at the time of contracting is set out in the Contract Form but may be subject to an annual increase, as notified to Licensee;

Authorised User: (i) any current student or member of staff of Licensee who is authorised by Licensee to access the Secure Network; and/or (ii) any individual granted temporary permission by Licensee to access the Secure Network whilst on Licensee's premises;

Commercial Use: for the purposes of direct or indirect financial gain (whether by or for Licensee, an Authorised User, or any other person or entity) by means of sale, resale, loan, transfer, hire or other form of exploitation of the Products. For the avoidance of doubt, Commercial Use shall not include use by Licensee or by an Authorised User of the Products in the course of research funded by a commercial organisation or recovery of administrative charges by Licensee from Authorised Users;

Contract Form: the form setting out the Products that Licensee wishes to either purchase or subscribe to, together with the relevant fees and, in relation to Subscription Products, the Subscription Period;

Fees: as applicable, the Subscription Fees, the Purchase Fees and the Annual Access Fee;

Licensee: the institution or organisation detailed in the Contract Form;

Licensor: The Chancellor, Masters, and Scholars of the University of Cambridge acting through its department Cambridge University Press of University Printing House, Shaftesbury Road, Cambridge CB2 8BS, UK;

Online Access: access to the Products on the Server;

Products: as applicable, Purchased Products and Subscription Products;

Purchase Fees: the fees set out in the Contract Form for the supply of Purchased Products;

Purchased Products: products which Licensee has purchased on a 'perpetual access' basis (i.e. the Licensee pays a one-time licence fee for the right to permanent access to the applicable products, although other charges may also apply);

Secure Authentication: Athens or Shibboleth (SAML) technology-based authentication, IP ranges, username and password, or such other authentication process agreed between Licensee and Licensor from time to time, and which is consistent with current best practice;

Secure Network: a network (whether a standalone network or a virtual network within the internet) which is only accessible to Authorised Users whose identities are authenticated by Licensee at the time of login (and periodically thereafter in line with best practice) by Secure Authentication;

Server: either Licensor's server or a third-party server designated by Licensor on which Products are mounted and via which they may be accessed;

Subscription Fees: the fees set out in the Contract Form for the supply of Subscription Products during the Subscription Period;

Subscription Period: the period commencing on the date set out in the Contract Form and during which Licensee and the Authorised Users may access the Subscription Products;

Subscription Products: products to which Licensee has subscribed for an agreed period;

TDM: Text and data mining; and

Terms of Use: the permitted uses and restrictions of use of the Products as set out in clauses 3 and 4.

2 LICENCE

2.1 Subject to payment of the Purchase Fees and, if applicable, the Annual Access Fee, Licensor grants Licensee a non-exclusive and non-transferable right to use and access the Purchased Products in accordance with the terms of this Agreement. Where Licensor is no longer able to provide Online Access on a permanent basis, it shall provide a copy of the Purchased Products in pdf format (or such other electronic format as Licensor in its sole discretion determines) and Licensee agrees and acknowledges that the use of any such electronic copy shall always be subject to the terms of this Agreement.

2.2 Subject to the payment of the Subscription Fees, Licensor grants Licensee a non-exclusive and non-transferable right to use and access the Subscription Products in accordance with the terms of this Agreement.

2.3 Subject to clause 2.4, any journal volume to which Licensee has paid to have Online Access for the Subscription Period shall continue to be accessible to Licensee via Online Access after that Subscription Period has expired, provided that this Agreement is not terminated by the Licensor under clause 10.2. This continuing access shall not apply to any content provided free of charge as an additional benefit to online subscribers. Licensee must pay an Annual Access Fee for continuing Online Access. The terms of this Agreement shall continue to apply to any journal volume to which access is granted after its Subscription Period has expired.

2.4 Where Licensor is no longer able to provide Online Access to the Subscription Products on a permanent basis, it shall provide a copy of the applicable Subscription Products in pdf format (or such other electronic format as Licensor in its sole discretion determines). Licensee accepts and acknowledges that, whilst Licensor cannot guarantee continued access, in the event a journal volume is transferred to another publisher, Licensor shall use commercially reasonable endeavours to negotiate such continued access rights with the new publisher.

3 PERMITTED USES

General

3.1 Subject to the restrictions in clause 4.1, and solely for the purposes of research, teaching at Licensee's premises and private study Licensee may allow the Authorised Users to:

3.1.1 access, view, download, store and print the Products; and

4 RESTRICTIONS

4.1 Except in the course of exercising rights specifically granted in this Agreement or permitted under any applicable Creative Commons licence, neither Licensee nor any Authorised User may:

4.1.1 remove or alter Licensor's copyright notice or other means of identification or disclaimers as they appear on a Product;

4.1.2 systematically make printed or electronic copies of any of the Products;

4.1.3 permit access to the Products to anyone who is not an Authorised User;

Pricing

Institutions are to receive unlimited online access, over a three-year period, to the Cambridge University Press Journals Annual Full Package. For 2017, there are 385 journal titles in the Full Package, valued at £113,795 (the online-only subscription value).

Members will receive access to our 2017 Full Collection and future annual collections through 2019 and benefit from unlimited OA publishing of accepted submissions in both our hybrid and wholly open access journals. The consortium price for this option is £381,439 for 2017.

- ❖ Participating institutions who have already renewed their 2017 subscriptions will be refunded as the value of these subscriptions have been taken into account in the 2017 pricing in this licence.

Subsequent year pricing, years 2018 & 2019:

- 2018 Consortium Price £411,954 – In the second year of the license, UKB members will be able to access our 2018 Full Collection and will continue to be able to publish in our hybrid and wholly open access titles without limitation within the 2018 Full Collection.
- 2019 Consortium Price £444,910 – In 2019, UKB members will have access to the 2019 collection and will continue to be able to publish in our hybrid and wholly open access titles without limitation within the 2019 Full Collection.

The increases for 2018 & 2019 represent 8% per annum. This increase is calculated as follows:

3% annual consortium increase + 5% new content for updated collections (2018 & 2019)

- ❖ We reserve the right to renegotiate the terms and pricing of this offer should our journal portfolio change due to unforeseen major acquisitions or if our Open Access Publishing increases exponentially.

New Institutions

Non-licenced universities may join the contract at any time during the course of the licence period. Additional fees per institution will be added to the total consortium fees.

Pricing for University Colleges and Research Institutions:

Access to the 2017 Full Collection or later collections are offered to university colleges and research institutes for a nominal flat fee of £2,500 per institute. The institution may cancel any individual subscriptions before the licence commences.

Unlimited Open Access publishing is not extended to these institutions.

Open Access Publishing:

The unlimited Open Access Publishing offered is only valid if at least 8 institutions license the 2017 Full Collection. Dutch (coordinating) authors affiliated with a licensed UKB member will be able to publish within both our available 261 hybrid journals and 20 wholly open access journals without

limitation. Due to society publishing policies the number of available hybrid and wholly Open Access journals can fluctuate from year to year. The policy of Cambridge-owned journals is to make all titles available for Open Access publishing.

General (applicable to all Subscription Products licensed through this Agreement):

During the term of this Agreement the Institutions shall be granted a discount of 50% off the GBP institutional print subscription price for any new or renewed print subscriptions to the Licensor's journals which have electronic equivalents.

DELETIONS OF JOURNALS

If Cambridge University Press ceases to publish a journal then this journal will no longer be available in the packages on offer. The availability of titles in Cambridge Journals Online Collections will be reviewed annually. Cambridge will notify SURFmarket of any titles leaving the list of available titles by 1 October in order to make applicable adjustments to the fees the following calendar year.

Should the value of the collection decrease by more than 10% year on year, then adjustments will be made to the Total Fees. By contrast, should the value of the collection increase by more than 10% year on year, we reserve the right to adjust the Total Fees. Cambridge University Press will communicate any such adjustments in advance.

SCHEDULE 6

Open Access

Terms and Conditions for Open Access Publishing for Authors

1. Eligible authors

Eligible Authors are defined as teaching and research staff employed by or otherwise accredited to one of the Institutions as well as students enrolled or accredited to one of the licenced Institutions.

In case of articles published by multiple authors, the corresponding author will be the Eligible author. Corresponding author shall be the author who signs the publishing agreement.

Authors are only eligible once they have signed the then current open access publishing agreement with Publisher. Currently this agreement refers to any of the below Creative Commons licences:

- Creative Commons Attribution License (CC-BY)
- Creative Commons Non-Commercial License (CC-BY-NC)
- Creative Commons Non-Commercial No-Derivatives License(CC-BY-NC-ND)
- Creative Commons Non-Commercial Share-alike (CC-BY-NC-SA)

2. Eligible Article Types

This agreement provides for unlimited publishing of research and review articles by Corresponding Authors within our hybrid and fully-OA journals.

3. The parties' obligations

a) The parties have the following obligations regarding the Open Access Publishing:

- Publisher shall not levy article processing charges directly on Authors who have identified themselves and whose eligibility has been verified;
- Publisher shall list and include the Institutions in the publishing process in order to assist Authors in identifying themselves at the time of submission;
- Authors will be deemed Affiliated Authors if the email address they provide to the Publisher is part of the list of domain names of the Institutions provided in Appendix
- Informational text in RightsLink (or whichever system the Publisher may utilize in future) will be displayed for authors linking to the Publisher's website for further details on the possibilities to publish in Open Access for free.
- Information regarding the agreed licence in regard to publishing in Open Access will be posted on the Cambridge Core website.
- Authors are given a choice in publishing routes at the time of submission. However, the Publisher's website will clearly be referenced to enable Authors to view the Open Access policies and allowances within this agreement.

- Institution shall ensure that Authors shall identify themselves as being both eligible and corresponding in the course of the Publisher work-flow. In case authors have not identified themselves as being eligible and corresponding, once an article has been published in a subscription Journal, the author is not eligible anymore to publish the article as Open Access;
 - The parties might change this identifying process and amend this Agreement accordingly, when the changes and amendments are agreed by both parties.
 - If the Agreement between Parties becomes available after the starting date, Parties will agree on publishing articles in Open Access for three years starting from 1 June 2017. Articles submitted by eligible corresponding authors qualify for Open Access publishing under this agreement upon acceptance date from or after 1 June 2017 through 31 May 2020.
 - Publisher will where appropriate provide an automated article upload service to PubMed Central.
- b) Publisher will deliver a monthly report per institute of the articles that have been published in Open Access in hybrid journals or fully OA journals in each month. The report gives an overview of the corresponding author(s), the affiliation of the corresponding author(s), the article title and journal volume, per institute. The report will be delivered within 4 weeks after the end of each month.
- c) Publisher will deliver a full report of all articles (open access and otherwise) published by the Institutions over the period 1 January until 30 June and 1 July until 31 December. The report gives an overview of the Institutions, the corresponding author(s), the affiliation of the corresponding author(s), the article titles, journal volumes and open access Y/N. The report is delivered within 4 weeks after the end of the 6 month periods. The report will be sent to SURFmarket, or an appointed contact person of the Institutions.
- d) Publisher is working to support the NISO Access and License Indicators Metadata, which we see as a useful standard. Currently, we record in JATS XML that the article is Open Access and which Creative Commons license is applied to the article.
